ORDER

The court has examined the “Motion for Preliminary Injunction” and supporting documents that plaintiffs filed on August 17, 2021 (Docket No. 16). Although the motion states that the challenged Executive Order (EO) No. 2021-058 “will go in effect tomorrow August 16, 2021,” the motion was not filed until 10:52 p.m. yesterday (Docket No. 16), and not on Sunday as plaintiffs imply. The motion is silent as to the delay in moving for preliminary injunction and does not refer to *any* harm suffered by *any* of the plaintiffs during the first two days of the effectiveness of EO 2021-058. The motion will be considered in a hearing. In this light:

1. Status Conference set for August 19, 2021 at 3:00 p.m. via VTC-Bridge PAD. Additional instructions with respect to the VTC will be notified to record counsel.

2. By August 26, 2021 at noontime, the parties shall file a joint informative motion in the accompanying format, with: (i) factual stipulations; (ii) factual stipulations proposed by plaintiffs and rejected by defendant, including defendant’s basis to reject the proposed stipulation; and (iii) factual stipulations proposed by defendant and rejected by plaintiffs, including plaintiffs’ basis to reject the proposed stipulation.

3. By August 30, 2021 at noontime, the parties shall file a joint motion indicating: (i) how many witnesses, if any, each party intends to call to testify at a hearing, and their names, with

a summary of anticipated testimony; (ii) list of expert witnesses each party intends to call at the hearing, if any, with a brief statement as to the anticipated testimony of such expert witness; (iii) the estimated duration of testimonies; and (iv) list of documents each party intends to use during that hearing.
